You and/or your lawyer will need to be present in court on that day; the Clerk of Court will mail a notice of the court date so please ensure a valid mailing address is included on the original motion.
- If the Judge grants the expungement, you will need to present him/her with the Order for expungement of Arrest/Conviction Record to sign in open court.
- If the expungement is granted you will need to get certified copies of any filings neededcertified copies are \$.50 per page plus an additional \$5.00 for certification of each copy; please be sure to get an adequate number of copies upfront, as you may not be able to get additional copies later once the files have been removed from public record.
- The State of Louisiana, District Attorney and Sheriff will be served with a copy of the judgment however; you will be responsible for serving any other agency with information about your charge on file.
- An expungement must be filed for EACH ARREST.

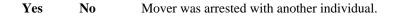
